Dear Resource Partners,

As you all know, the best time to craft a business resiliency plan is before you go into business. The next best time is now.

An actionable resiliency plan could mean the difference between business continuity under adverse conditions and business closure.

This special edition of the Washington SBDC Biz Buzz newsletter contains information about business resiliency webinars open to any business owner in the state at no charge. Please forward this newsletter to anyone or any organization that has ties to the small business community.

Starting this Thursday (March 12) we will be offering a series of one-hour webinars to introduce business owners to resiliency planning and the “Keeping the Lights On” guide. Webinar participants will also receive access to a business resiliency PDF fillable form that they can customize according to their particular needs. About 30 minutes of the webinar will be an overview of resiliency planning and the remainder of the time will be for questions and answers.

Even though these are online trainings, we are asking participants to register for the time set aside for their communities (or closest to) so that they can learn about local resources for further assistance. For instance, participants in Spokane should register for the workshop at 11 a.m. on Thursday, March 12. Keith Davis will be presenting the overview, but we intend to have SBDC advisors from the Spokane region sitting in on the webinar to answer questions and provide additional resources. In addition, an on-demand webinar should be available soon.

The webinar will not specifically cover health concerns of the Coronavirus. Instead, it will be focused on sustaining a business during a crisis.

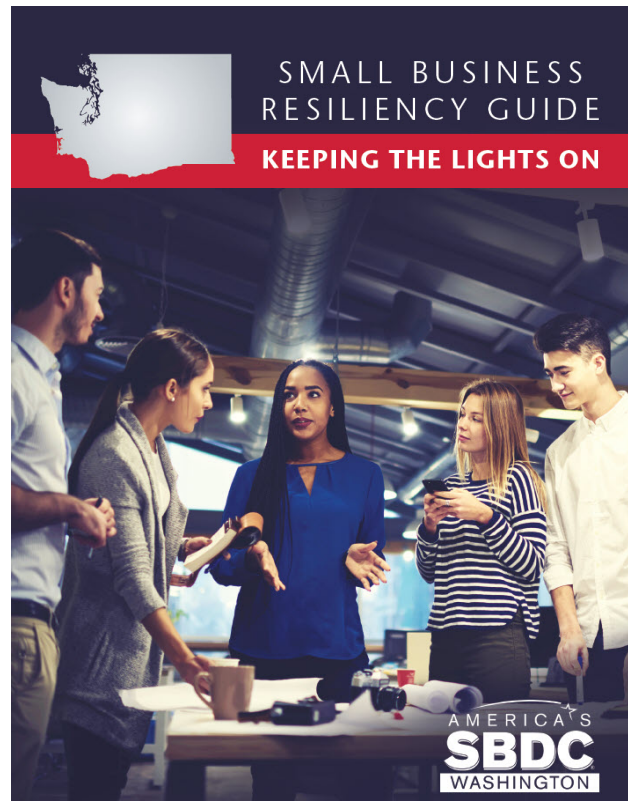
